We understand the only land in the new proposal to be built on in Gedney South, in the next twenty years is Markillies Yard, the land around Gatehouse No. 87 and Hunts Corner leading to Fleet Hargate. We are in agreement with this providing measures are taken to improve the sewage situation. We are constantly having problems at the pumping station which involves lorries coming and going 24 hours a day. Sewage can be smelt at times along Stonegate, possibly due to the difficulties they are having with sewage getting backed-up. To add further properties to the sewage system that cannot cope a lot of the time at present, is only asking for more problems.

In addition to this I should mention that we frequently get electrical power cuts along Stonegate. We are never given a reason why, but that may have its own implications if further new properties are developed along the road.
